\_\_\_\_\_ Candidate must complete a satisfactory credit check and must not have been convicted of a felony or crime involving dishonest or breach of trust, nor have been determined to be guilty of a fraudulent act by a legally constituted body.

\_\_\_\_\_ I authorize Western Vista Credit Union to validate my membership status and perform whatever credit and background checks it may deem necessary. I agree to fully cooperate with the nominating committee and/or the staff with respect to verification.

\_\_\_\_\_ Candidate is prohibited from engaging in any act which is, could be or could appear to be in conflict with their status as a volunteer. This includes one's position with the credit union for personal profit or advantage.
